Legislative Update

As you may remember, the Texas Legislature meets from January to May in odd-numbered years. This year was no different.

We would like to provide a few highlights of some positive things that recently happened with some good prospects for the future. The previous session focused on shoring up the Teachers Retirement System, this session was time to do the same for ERS Fund, one of RSEA's top Legislative Priorities.

First, during the recent regular session of 87th Legislature, there were two important and positive legislative actions.

There was Senate Bill 321, sponsored by Senator Joan Huffman of Houston, along with House sponsor Representative Greg Bonnen of League City, putting our Employees Retirement Fund on an actuarially-sound path for the future.

With an initial \$1+ billion in House Bill 2, the supplemental appropriation bill, a proper payment schedule to the retirement fund has now started. SB 321 also directs ERS to develop a new "cash balance defined benefit" program for new employees; it does not affect current retirees or employees. This plan is like the plans for current municipal and county employees in Texas. It has a shared benefits and risks to both employees and the State, including a guaranteed minimum of 4% gain sharing. This new approach will apply only to those state employees hired after 09-01-2022. It has been mischaracterized, in our opinion, as "just another 401(k) program."

Going forward, RSEA plans to work with ERS and legislative leaders in the coming biennium to ensure good implementation of SB 321 to the benefit of all future employees and retirees.

This legislation also serves as a positive step in addressing the state's unfunded liabilities as a

means of protecting the state's credit rating, a matter which State Comptroller Glenn Hegar has often discussed.

Passage of HB 917

Then, there is House Bill 917 by Representative Ana Hernandez (RSEA's 2019 recipient of the Aikin Award, see our September 2020 newsletter) and Senate sponsor Senator Eddie Lucio, Jr., which now enables a retiree to stand for election to the ERS Board of Trustees as one of the three elected employee representatives. With this new law, it will now be possible for a State Retiree to sit at the decision-making table when key policy decisions are being made by the ERS Board. That means the next election in 2023 may include a spot for you!

Both bills relate to long-standing top priorities of RSEA, and you can see our letters to Governor Abbott supporting their enactment on our RSEA website at www.rseaoftx.org.

Legislative Coalition

We want to give a special recognition to an informal coalition of retiree and current employee associations which came together this session to help educate the Legislature on the best possibilities for addressing the long-term financial sustainability of the ERS fund. Therefore, we want to personally and publicly thank the leadership of these organizations for coming together to provide a united message to Legislators: Texas Public Employees Association, Texas DPS Officers Association, Texas Game Warden Peace Officers Association, AFSCME Texas Retirees, and Association of Texas Liquor Enforcement Agents. This was an unprecedented initiative on behalf of all 250,000 retirees and beneficiaries, and current, as well as future, state employees, and we were all proud RSEA was part of it.

Our work together helped educate the Legislature on the needs of the Fund and our support for action to address those needs. RSEA News Page 3

Marie Moore, 1st Vice President (formerly w/ Bond Review Board) has served on the Board since 2007 and as 1st Vice President since 2013. She held offices in the Texas State Agency Business Administrators Association and was the first woman named Administrator of the Year in 2003.

Willie Piña, 2nd Vice President (formerly w/ Dept of Human Services) has been on the Board since January 2002, with previous positions as President and Treasurer.

Elena Diaz (formerly w/ Office of Attorney General) served on the Board since 2019 and began serving as Treasurer in 2021. She also retired from Travis County as Justice of the Peace and still works as a visiting judge.

Dona Medlock (retired from Comptroller of Public Accounts) has served on the Board since 2017. She returned to work at CPA as Director of the Enforcement Division. Her duties include overseeing the collection of state taxes and fees, and management of field offices.

Denice Bettencourt (formerly w/ Dept of Transportation) has been on the Board since 2019. She's held board and committee positions and continues to be active in local non-profits.

Eliza May (formerly w/ Funeral Service Commission) held multiple roles in state government. She has served on the Board since 2019. Since retiring, she dedicated time to researching public policy issues. She has also served on numerous boards of non-profits. ■

2020 Annual Meeting Highlights

Our September 24, 2020, RSEA Annual Membership Meeting was the first "virtual" conference; this was one of many firsts we all experienced last year.

Despite the many stresses and strains of 2020, our RSEA Annual Meeting was informative, congenial, and successful.

We had 126 registered attendees from around the state. A total of 23 people won a total of \$1,200 in door prizes. Door prizes were highly anticipated and twenty-two winners each received a \$50 VISA card. Jon Cradit of San Marcos was the winner of the grand prize: a \$100 VISA card!

Porter Wilson, Executive Director of our Employees Retirement System explained the agency's needs and requests they had made to the 87th Legislature. The primary "ask" was for long-term, consistent funding to get the retirement fund to an actuarially sound level.

Phillip Ashley, Associate Deputy Comptroller for Fiscal Matters at CPA, provided an update on the state's fiscal condition for the 87th Legislature.

Rachel Ciullo, UT Austin LBJ School of Public Affairs introduced our new agreement to promote public service in state government by sponsoring 4 graduate student scholarships over each of the next 5 years.

The business meeting included financial reports and election of directors and officers. Online communication was enabled to encourage member participation in the discussion.

Because it was virtual, we were unable to have onsite exhibitors. However, we were most fortunate to have as sponsors:
